Undertaking by parents/Guardian

I or local guardian will personally pick my ward. My ward will join back after complete recovery and with a medical fitness certificate from the concerned medical practitioner.
- 10. If my ward leaves the school campus or the hostel without permission, the school authorities may lodge FIR with the local Police Station. I have no right to question and raise objections to this action. The school will not be held responsible in the event of any accidental mishap or untoward incident in such circumstances.
- 11.
